Appellants Lawrence and Aileen Makovich were present and demonstrated why the Town of Harrison's assessment of their property was unjust discrimination. They expressed the position that using a 125% factor applied to their land is arbitrary and not explained.

The Harrison Town Assessor John Wentworth represented the Town of Harrison and presented testimony of his position.
