Bulletproof Vest Partnership Grant

Greetings, after a discussion with Alex Kimball, I was advised to put this grant request into a memorandum form. The grant is the 2024 Patrick Leahy Bulletproof Vest Partnership grant administered through the Bureau of Justice Administration. The grant, if awarded, provides funding for reimbursement of up to 50% of the cost of ballistic vests for the agency's law enforcement officers and armed corrections officers. One of the primary determiners of the grant award is the agency's crime statistics.

The grant period runs from April 1, 2024 through August 31, 2026. The reporting/reimbursement requests have been online in the past and have been completed by me. The only documentation required in the past from Finance is proof of payment.

The total funding for these vests is included in the agency's budgets. If approved, this simply an opportunity to be reimbursed for up to 50% of the cost of the vests. The reflected vest cost includes the ballistic panels, the carrier for the panels, and a soft trauma plate.

The following is a breakdown of projected cost at current pricing for both Corrections and Law Enforcement:
