Energy Efficiency and Conservation Block Grant Program Awards

There are 2,708 state, local, and Tribal governments eligible for a formula award from the Energy Efficiency and Conservation Block Grant (EECBG) Program. The U.S. Department of Energy will announce these awards on a rolling basis.

Local governments and Tribes may choose to receive their EECBG Program awards as a grant or through vouchers for equipment rebates and/or technical assistance. The voucher option offers a streamlined way for communities to access and use EECBG Program dollars.

Communities across the country are investing in projects and programs that save energy, reduce climate pollution, and advance local energy goals. The below table summarizes the awards made to date. As of November 12, 2024, DOE has awarded a total of **\$196,388,975** in EECBG Program formula funding to **294 communities**.

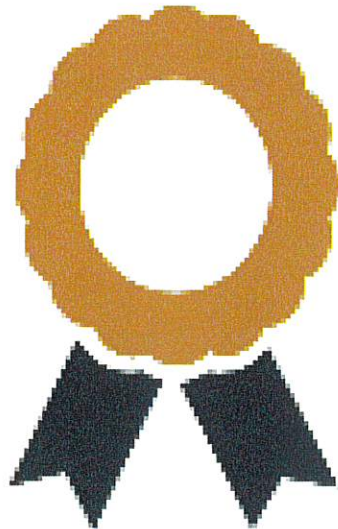
