

<u>CD 23-018</u> Presentation of the proposed Cumberland County UMaine Cooperative

Extension for 2024 - 2025 grant funding.

University of Maine (UMaine) Cooperative Extension Administrator Sara Davenport presented a summary of the programs supported by the UMaine Cooperative Extension in Cumberland County. Programs included Harvest for Hunger, Norm Steele Memorial Seed Grant Projects, 4-H programs, Workforce

Development, Paths and Falmouth High School, Maple Producers, USDA grant for Agricultural Literacy program and Maine Horticulture Apprentice Training.

President of the Extension Association Board Valerie Jones stated that the Board meets on the third Wednesday of each month. She explained the design of the 4-H program and how training is passed on. Theresa Kelley, Pownal, spoke about the Master Gardner Program that needs to be expanded. It has a waitlist of 700 people but the program can only administer 15 each year. She thanked the Board of Commissioners for their support and Commissioner Cloutier for attending the community meeting. Board Member Tim Schmidt, Pownal, spoke about the variety of programs that teach individual skills that strengthen the community. Commissioner Gorden said he heard really positive things about the 4-H program.

Remand the proposed 2024/2025 County Manager Budget to the Finance Committee for their review and recommendation.

County Manager Gailey gave an overview of the transition from a calendar year budget to a fiscal year budget. He thanked Deputy Manager Kimball for the smooth transition. County Manager Gailey reviewed the various budget changes; increased benefits for Unions including a change in the MainePERS plan; higher software costs; increased vehicle costs purchase for fit-up, maintenance, and parts; a Non-Union COLA increase of 3%; health insurance plan increase of 7% for POS C and 10% for PPO 2500; additional one and half new positions for an administrative position and six months of the County Recruiter originally funded by ARPA. He stated that County positions funded by ARPA are now limited to 2024. The Public Health Director and Behavioral Health Director will be covered 100% by the MPN after 2024-25 while the Grant and Compliance Manager will be funded until the end of 2026. County Manager Gailey reviewed total expenditures and revenues. The TAN loan decreased by \$70k; there is no General Obligation Bond, total needs from taxes for the County, the Cross Insurance Arena and the Jail are 4.86%.

County Manager Gailey stated that the finance committee would meet at 5:00 pm on December 19th, January 16th, January 30th, and February 20th in the Peter Feeney Room.

County Manager Gailey stated that the Jail Budget was impacted by lower staffing and absence of Federal Inmates and would hear back from Federal Marshalls regarding the Federal Inmate Boarder Contract, Commissioner Cloutier stated he would be interested to know how lower staffing levels and the current low incarceration rate effect operational costs. County Manager Gailey said he would find some numbers.

Commissioner Gorden asked if there was State Funding for the Jail, County Manager Gailey replied that the County was capped at 4%. County Manager stated that the Jail Budget was not final and that the Federal Inmates will affect the final budget. Commissioner Gorden said that he is working with the Maine County Commissioners to secure State funding for County jails.

Commissioner Witonis asked when the Federal Inmate contract would be finalized, County Manager Gailey answered that it would be mid to late January 2024.

Commissioner Smith asked about the Federal Boarders and about the gap of 54% and the budget that has to be addressed. Deputy Manager Kimball stated that it's not a real change but it's more of a timing issue that will be resolved when the Federal Boarding Inmate contract is executed while gradually adding additional staff.

Chair Jamieson encouraged Commissioners to attend at least one of the Finance Committee meetings.

He shared that Department of Public Health Angela Giordano is representing the 35 Under US Women's Field Hockey Team in Buenos Aires.

#### COMMENTS FROM THE EXECUTIVE STAFF

Deputy Manager Alex Kimball shared that he is excited about the future contributions that Director of Finance Grover will make.

Director of Finance Grover thanked the Commissioners.

Human Resources Director Amy Jennings shared there are 40 open positions, two thirds are public safety, and employee open enrollment just closed.

Director of Public AffairsTravis Kennedy shared that he is collaborating with Sandra Warren on DEI

program that will be a seven year plan. A task force group will meet monthly. He also shared that there is a kiosk in the entry way of the Courthouse that summarizes the energy generated and saved from the solar farm that the County has contracted with. The Regionalization of the emergency Services Report is in progress.

### COMMENTS FROM THE COUNTY COMMISSIONERS

Commissioner Gorden shared that the LD 630, is a carry over funding rural patrol for smaller counties. The State Police would be responsible but the Counties have taken over. The costs have shifted from State budget to the property tax budget. He thanked the Commissioners and the county staff for their help.

Commissioner Cloutier wished everyone a Happy Holidays and appreciate everything they have done. As the new Chair, he invited the Commissioners to reach out about items they're concerned or interested in sharing at meetings.

Commissioner Smith stated that she was excited about the listening session that would take place in Windham. It's important work that the County can contribute to address Homelessness.

Commissioner Jamieson thanked staff for their work and wished everyone Happy Holidays and the Peace of the Season. Looking back at the budget accomplishments, the Cross Insurance Arena was at a loss and it's wonderful to watch things turn around and improve.

# **Requested Action:**

Approve the dedication of our new Victim Witness Waiting Room as the "Lois Galgay Reckitt Victim Witness Waiting Room."

# **Background & Purpose of Request:**

In January of 2023, I observed a victim waiting to give testimony in a criminal trial spending the better part of a day on the wooden bench directly outside of the courtroom. In addition to being of questionable comfort, this subjected her to negative comments and stares from those going in and out of the courtroom, many of whom were there in support of the Defendant. My office informed me that in the long history of this building, there has never been any other place for victim-witnesses to be during trial. In the following weeks, another victim was reportedly bullied while waiting to testify, again seated on the hard benches. Another waited most of a day accompanied by her minor child and another adult - the child trying to find a comfortable way to sit on the marble flooring, until I made the small conference room adjacent to my office available. That room has since been regularly offered to victim witnesses, but that is not always possible.

Most modern courthouses are built to include a victim-witness waiting room, not visible to Defendants, other witnesses, or observers who may have an opinion about a trial. I began looking for an appropriate space in March of 2023. My assistant, Abbey StClair, took the primary responsibility to clear out half of a large former hallway filled floor to ceiling with old files and memorabilia. This space is outside of the Law Court, and adjacent to my office. The County began constructing a new wall and door in late October. This small (6.5' x 12') but cozy space will be painted before the end of January, and we are on the hunt for appropriately-scaled furniture. All of the work has been graciously paid for with County funds, and I am very grateful for the consistent support of our Manager at every step in making this happen.

The room's construction neared completion just as we lost one of Maine's most notable and fierce advocates for justice for victims, Lois Galgay Reckit. Lois's well-known determination to secure justice for survivors of domestic violence and the underserved is written throughout Maine's laws, in our state's commitment to advocacy, and in the roadmap she left us to finish her lifetime of truly inspiring work. Her family and the County Manager join me in support of dedicating the new Victim Witness Waiting room to Lois. I hope to have your support. We plan a small dedication ceremony in February.
